The FEMA Review Council created by Executive Order on January 24 has been posted in the <u>Federal Register</u>. To my knowledge, no one has yet been officially named to the Council. More on this to come as more details become available

The "AM Radio for Every Vehicle Act" $(\underline{S.315}/\underline{H.R.979})$ has been reintroduced in both the House and Senate

Here's some good news...the management cost bill has officially been re-introduced in the House by Congressman Neguse (D-CO). The new bill number is <u>HR 744</u>. I expect the companion bill in the Senate to be re-introduced soon.

What IAEM is Doing

IAEM staff and member groups are actively advocating for the transition of disaster management responsibilities to be structured, sustainable, and not compromise community safety. Our priorities include:

- Engaging with policymakers to slow the pace of change and facilitate meaningful conversations about the long-term impact of these shifts.
- Requesting an IAEM presence on the newly established FEMA Review Council to advise on changes.
- Advocating for state and local solutions to help bridge gaps in capability as federal funding sources change.

What You Can Do

Advocacy Resource Center: This site will serve as a one-stop shop for members engaging in advocacy, including legislative talking points and sample letters to lawmakers.
