

## IAEM Certification Online Exam Steps

1. Complete the IAEM Certification Examination Request online form with Candidate's contact information, approved Proctor's contact information and date of the scheduled exam. 14 business days advanced noticed is required. Note: Candidate is not permitted to take the online exam on his/her personal or work computer. The Candidate must use a computer with Internet connection provided by the Proctor.



### EXAMINATION REQUEST

#### IAEM Certification

IAEM offers candidates for the Associate Emergency Manager (AEM®) and Certified Emergency Manager (CEM®) designations the opportunity to take the certification exam online. To request an online examination, you must:

- Complete the Examination Request Form below
- Select a date to take the exam – **An advance notice of 14 business days is required!**

- Pay the IAEM Certification Fee – For more information on fees and making payments online, [click here](#)
- Ensure your testing location has a reliable Internet connection and computer. Internet Explorer, Edge, Firefox, Safari or Google Chrome are required to log into the exam.

IAEM reserves the right to deny your exam request should the proctor not be approved. As a reminder of who can be an approved proctor:

The proctor must be an unbiased party and must be someone from:

- IAEM Staff will review the exam request within 14 business days and confirm the Proctor is eligible to proctor the exam.
- Proctor will receive an email from “IAEM Exam System” with the subject “Request to Proctor the AEM/CEM Exam for [Candidate’s Name] on [date] – ACTION REQUIRED”. It is the responsibility of the Proctor to read the email and the attached “Proctor instructions” document and complete the electronic Proctor Agreement (link provided in the Proctor’s confirmation email) at least 5 days prior to the scheduled exam.

- Once the Proctor Agreement has been received by IAEM HQ, Candidate will receive an email from IAEM Exam System with the subject “AEM/CEM Exam Confirmed for [Candidate’s Name] – [date of exam]”. 7. On day of exam, the Proctor will review the information in the document 'Proctor Instructions' with the candidate. Candidate must bring a photo ID to the exam. Candidate will take the online exam in the Proctor's presence using the login information provided by the Proctor.
8. The candidate will receive the results of the exam (within 14 business days) via email.
