

GOVERNMENT AFFAIRS NEWS

Last month the House Transportation and Infrastructure Committee, which has primary jurisdiction over most emergency management



related policy issues, convened to mark-up a number of bills of interest to emergency managers. Overall, the results were primarily in our favor with a majority of the bills we endorsed being passed out of committee. You can review the bills endorsed by IAEM that were favorably reported out here:
